Violent conflicts set people into motion, change existing social relations, and often lead to new mobilities and transnational practises. This two-day symposium, which is co-organised by the IMISCOE Standing Committee on Migrant Transnationalism (MITRA) and the BMBF-funded project Forced Migration and Refugee Studies: Networking and Knowledge Transfer (FFVT), seeks to unpack how transnational mobilities and connectivities come into being and change under the conditions of war, and how they shape the lives of those who are transnationally (dis)entangled.
